Vice-Chairman Blanchard stated that public comments can be made at any time in the regular meeting prior to action on any agenda item upon which a vote is to be taken.

Judge Walter Lanier III swore in new Commissioner Jeray Jarreau.

Mr. Eric Dalamore reported the updates to the Pump Capacity Improvements Project (PCIP).

Mr. Rabalais asked to add Change Order No. 7 for the PCIP.
